

Canine Classic Spa & Resort Boarding Contract

1. All dogs must be current on their vaccinations. Proof of the following must be provided before or at the time of check-in: Rabies, Distemper/Parvo & Bordetella.
2. Canine Classic Spa & Resort reserves the right to prohibit admittance of pets lacking proof of vaccination, clear fecal or showing signs of untreated or potentially contagious conditions.
3. If external or internal parasites are found, they will be treated to prevent exposure to others. The owner of the pet will be responsible for the expense.
4. Canine Classic is not responsible for lost or damaged personal belongings.
5. Any pet left unclaimed for 30 days beyond specified check-out date, will be considered abandoned and be handled accordingly to Illinois Law.
6. There will be a \$5.00 Pet Care Warranty fee for each pet boarded. Our warranty program covers up to \$300.00 on most medical expenses, occurring during or with in 5 days of their stay. It does not cover pre-existing conditions or Bordetella (Canine Cough).
